## Willow Park Greens HOA Meeting

- Meeting called to order at 7pm
- Lt. Roy Guinn with Harris County Constable Precinct 5 came to speak to the community.
  - Spoke about safety in the neighborhood. There's really no difference between the sheriff, a constable and a police officer. They have a few different duties, but that's about it. The constable patrol program was started about 20 years ago. Neighborhoods have contracted with the constable's office to have an officer patrol. This allows for more officers on the streets (roughly 250 officers). Constable Heap created district units and are assigned to patrol everywhere.
  - As a board, we have looked into private security or patrol units. Lt. Guinn says he
    doesn't think it's necessary because we have a low crime rate in our
    neighborhood.
  - He would caution against private security. The cost is about the same, but they
    have no arrest power and their training isn't extensive. If they see something,
    they will be calling the police or constable.
  - o There is crime in our city, but inside our community, it's very minimal.
  - Neighborhood Watch it's not the same as citizens watch. With Neighborhood Watch, no one signs up, it's just changing the way people think when they leave their house. When you're outside of your house and in the neighborhood, be on the lookout. Pay attention to your surroundings and anything that's amiss or suspicious.
  - It is difficult to get someone to come out and check on something suspicious unless it's an emergency situation.
  - Consider classes on safety most of them focus on awareness. Consider different situations for yourself and what you would do in those situations.
  - BE COMPLETELY AWARE OF YOUR SURROUNDINGS
  - The constable's website has a lot of info on it along with the classes they offer.
  - Fort Bend County residents are welcome to attend to classes
  - Is there a local Fort Bend police office in our area? It's likely the Harris County Constable's Office on Barker Cypress. When someone calls in to 911 they are automatically sent to the correct station that covers their address.
  - O Knocking on doors is an MO for burglars. Try and answer the door (through the door) to let the person know you're home. It's not very often someone poses as a police officer, but there are people who pose as utility workers.
